PRECAUTIONS

STORAGE: Keep out of reach of children. Store in the original container in a secure place. Storage of certain quantities of this product trigger specific storage requirements (Refer to HazNote).

PERSONAL PROTECTION: Avoid contact with eyes and skin. Avoid inhalation of spray mist. When mixing or applying, wear overalls, boots, gloves, and eye protection. Clean protective clothing daily after work. Do not eat, drink or smoke while using. Remove protective clothing and wash hands and face thoroughly before meals and after work.

First Aid

Spillage

MIXING

Pour the correct quantity of herbicide into the partly filled tank, then add the remaining water with agitation. Add the Silmaxx last when the spray tank is almost full while ensuring there is adequate agitation.

COMPATIBILITY

Compatible with glyphosate, metsulfuron and other brushweed herbicides.

RAINFASTNESS

Rainfast 30 minutes after application.
